KNOW ALL MEN BY THESE PRESENTS, That we, Wade Bayard Marvin and William Sellers Marvin, in the State aforesaid, for and in consideration of the sum of FIVE AND NO/100 (\$5.00) DOLLARS, LOVE AND AFFECTION FOR OUR MOTHER, to us in hand paid by Sherry Marvin Hughes, 3960 White Hall Road, Green Pond, SC 29446, the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sherry Marvin Hughes, her Heirs and Assigns forever, all of our right, title and interest in and to the following described real property:

TRACT 1: All those certain pieces, parcels or lots of land, with buildings and improvements thereon, situate, lying and being in the City of Walterboro, County of Colleton, State of South Carolina, being known and designated as Lot Nos. 

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
